BALL FIELD ADMINISTRATIVE RULES, FEES AND GENERAL CONDITIONS FOR USE:

- The fee shall be \$30/day or \$30/game whichever is greater, or \$15/practice.
- South Salem Little League shall receive priority scheduling based on the terms in their lease agreement with the City of Turner at the time of reservations.
- Any other organized group which uses the field must reserve the field with the City.
- The City Administrator shall have the authority to adopt administrative rules which shall contain the following requirements at a minimum
 - a) All groups reserving the field shall show proof of \$1,000,000 of liability insurance naming the City of Turner as an additional insured.
 - b) All groups shall adhere to any other applicable State, County or City regulations governing activities and behavior in the Parks.
